Dehradun: Dated 5th May, 2021

Subject: Prevention and control of spread of Covid infection.

Madam/ Sir,

1. Keeping in view the fresh surge of Covid infection, the District Magistrate of district Dehradun, Haridwar and Udham Singh Nagar, are directed to enforce Corona Curfew, throughout the district, from 6th to 10th May (till 5AM), 2021.
2. Other District Magistrates are directed to assess the situation of Covid infection in their districts and based on their assessment of the situation, may impose Corona Curfew from 6th to 10th May (till 5Am), 2021, with a view to contain the spread of Covid-19 infection.
3. However, there shall be no restriction on inter-state and intra-state movement of persons and goods.
4. All industries, Goods vehicles, construction work and other essential services will be allowed to operate. The ration shops (on alternate days), milk booths, vegetable shops will be allowed to operate till 12PM only.
5. All District Magistrates are authorised to issues district specific guidelines as per their assessment.
6. All government offices shall be open as per order number 329/XXXi(15)G/2020-04(Saa)/2021 dated 28th April, 2021.

All concerned are directed to ensure compliance of the aforesaid guidelines and direct all authorities concerned for its strict implementation. Further, guidelines issued by MHA and consequent orders issued by the state government should be widely disseminated to the public and to the field functionaries for implementation.


Subject: Prevention and control of spread of Covid infection.

Madam/ Sir,

1. Keeping in view the fresh surge of Covid infection, the District Magistrate of district Dehradun, Haridwar and Udham Singh Nagar, are directed to enforce Corona Curfew, throughout the district, from 6th to 10th May (till 5AM), 2021.
2. Other District Magistrates are directed to assess the situation of Covid infection in their districts and based on their assessment of the situation, may impose Corona Curfew from 6th to 10th May (till 5Am), 2021, with a view to contain the spread of Covid-19 infection.
3. However, there shall be no restriction on inter-state and intra-state movement of persons and goods.
4. All industries, Goods vehicles, construction work and other essential services will be allowed to operate. The ration shops (on alternate days), milk booths, vegetable shops will be allowed to operate till 12PM only.
5. All District Magistrates are authorised to issues district specific guidelines as per their assessment.
6. All government offices shall be open as per order number 329/XXXi(15)G/2020-04(Saa)/2021 dated 28th April, 2021.

All concerned are directed to ensure compliance of the aforesaid guidelines and direct all authorities concerned for its strict implementation. Further, guidelines issued by MHA and consequent orders issued by the state government should be widely disseminated to the public and to the field functionaries for implementation.


